It is submitted that the IGNOU Study Centre was working in the college from 2012-15 but due to regular competitive exams in the college on Sundays it was difficult to run the course (MA Psychology) on Sundays as the classes were held only on Sundays. But, now days, maximum of the competitive examinations have adopted online conduction and on Sundays the college is almost free from all such hurdles. The IGNOU is interested in establishing its study centre in the college. Earlier a MOU was signed between the then principal and the IGNOU authorities (copy attached) and if permitted the same will again be signed so that the centre can be restablished. No financial liability of the institute will be there, rather, the revenue will be generated through the utilization of existing infrastructure of the college on Sundays only.

Besides above ail, during the inspection by the NAAC team in September 2015 it considered different parameters to evaluate and give accreditation to the institute on following grounds like examination system, student's strength and facilities, sports facilities, facilities for the mass provided through physical fitness activities, day care centre, SWOT analysis of the institute in addition to these there was a credit system for distance learning mode but the college doesn't have any distance learning course. Thus, the Distance learning centre of IGNOU in the college can be established. This is important for the distance learners and the college to earn the credits and enhance the gradation of the college as per NAAC parameters.

- 5. Appoint Part-time Class-III and Class-IV staff and other Study Centre functionaries on the basis of recommendation of the Coordinator and pay them remuneration at the rates in force from time to time.
- 6. Pay an honorarium to the Head of Institution for general supervision of the Study Centre as fixed by IGNOU from time to time.
- 7. Have the right to shift or close the Study Centre if it finds that support services are not being provided, as per the requirements of the university. In such case the Coordinator would have to hand over all the assets and academic records of the learners to the Regional Director. The Coordinator will also have to settle all financial accounts with the Regional Directors.
